### Chairman's Report

## Secretary's Report

Lobo made a motion, seconded by Jack Elsbree, to accept the minutes of the regular July 17, 2010 meeting. The motion was approved.

We have applications for Independent membership from Richard Griffth, Elmer King, and Armando Ramirez.

Bob presented a donation \$232 from PWA campers toward the new restroom facility.

## <u>Treasurer's Report</u>

Lee thanked everyone for keeping their dues, site fees, etc., paid. Lee reminded everyone that our calendar year is January through December. If you are going to pay annually, please pay from January through December. If you wish to be billed annually, please let Lee know.

Lee mentioned he has received some bad checks and that we do not have a bad check fee. Lee said he'd like to propose we have a bad check fee of \$25.

Dale Arndt made a motion to establish a Texas Conference of Clubs bad check fee of \$25. Motion seconded by Lobo. After discussion, Lobo called for the question. The vote on calling the question was approved. Rick abstained.

The vote for the back check fee was 7 for, 4 against. Motion carries.

Danny Russell made a motion to amend the bad check fee to \$15. John Szew-cyzk seconded the motion. 3 in favor, 6 opposed, 2 abstained. Motion failed.

## Committee—Coordinator Reports

### Land Management

Brian went over his report. Some highlights of his report:

Brian mentioned again that he was going to start mentioning names when things occur.
